Code of Conduct

Individuals are responsible to abide by the following while on our campus. Group leaders are accountable to FDM staff regarding their group's adherence to these guidelines. We reserve the right to ask any group member, or group, to leave the premises, without a refund, if found to be in violation of this code. Please check each item to indicate you have read, understand and agree with each item:

- ☐ Parents are responsible for their children's behavior. Children must be supervised by an adult from your group at all times.
- ☐ Your group may be held financially responsible for damage to FDM equipment or spaces.
- ☐ FDM will add cleaning charges if more than normal cleaning is required in any of the spaces your group has used. Please leave any guest rooms and meeting rooms as you found them.
- ☐ There is no use of cooking implements in the sleeping or meeting rooms other than those provided by FDM; this includes but is not limited to hotplates, microwaves, chafing dishes/sterno heaters, or camp stoves.
- ☐ ***There is no use of candles in the meeting rooms or Guest Houses.***
- ☐ Abusive, offensive or profane language will not be tolerated. This includes misuse of the Lord's name.
- ☐ Smoking, e-cigarettes and/or the use of tobacco products are not permitted. Alcoholic beverages, illegal drugs, weapons, and fireworks are prohibited from the grounds.
- ☐ Practicing sexual immorality is not permitted. This prohibits the sharing of a room by unrelated persons of the opposite sex.
- ☐ Quiet hours are between 11:00 pm and 7:30 am. Please be considerate of our other guests while on the grounds or in your Guest House: behave so you cannot be heard by other groups/guests who are here.
- ☐ Guests are to be dressed in modest apparel.
- ☐ Tampering with the fire alarms and related equipment is prohibited, dangerous and illegal.
- ☐ Guests may not be on the grounds of Day Camp Sunshine when it is in session, or interfere with camp operations in any way.
- ☐ Guests may not enter Sunshine Preschool & Infant Care when the Preschool is in session, Monday – Friday, 7am – 6pm, year round.
- ☐ The swimming pools are only to be used only when a lifeguard employed by Fellowship Deaconry Ministries is on duty. Women should have one piece bathing suits and men should have boxer style swim trunks. Children must be supervised by an adult from your group.
- ☐ For the protection of our guests and staff, guests are strictly prohibited from entering the Ropes Course area or using the Ropes Course equipment in any way, unless they are under the supervision of an FDM approved certified instructor. Children must be supervised by an adult from your group. **Anyone found in violation of this rule will be asked to leave immediately. If the guest is a member of the group, the entire group may be asked to leave. No refund will be issued.**
- ☐ Limitation of Liability: You understand you and the members of your group are present at the Fellowship Deaconry facility at your own risk. Liability for any injuries or illnesses you or any member of your group sustain personally, or damage to your equipment or belongings, while using this facility shall be limited to coverage provided to you by your group, or coverage provided by Fellowship Deaconry insurance provisions.
